# **Booking Process**

## 1. Initial Booking

- Provide access information
- Full payment due 14 working days before event

## 3. Event Requirements

- 120-minute setup time required
- Minimum 10 participants
- Floor protection required for carpeted venues
- Suitable venue space needed
- Access to water required

# **Changes & Cancellations**

- Free cancellation up to 14 working days before
- Booking fee non-refundable within 14 days
- Free date changes outside 14 days
- Additional guests can be added on day
- No refunds for reduced numbers within 14 days



# **Photography & Social Media Policy**

- We photograph our events for promotional purposes, social media platforms and website
- Participants must inform us before the event if they do not wish to be photographed
- We respect all opt-out requests if notified in advance
- By attending our events, you consent to photography unless you opt-out
- We cannot guarantee exclusion from photos if not notified before event

- Photos will be stored in accordance with GDPR guidelines

- Ticket includes art box
- Access link provided upon payment
- No recording or sharing permitted
- Non-refundable once event starts
- Rescheduling subject to availability

- Access to exclusive online sessions
- Non-transferable login details
- Cancel anytime
- No sharing of access or discount codes
- Monthly payment non-refundable
- Members-only benefits

- 28-day return if unopened

- Cancellation more than 14 working days before event:
  - o Full refund available including booking fee
  - Free date changes available
- Cancellation within 14 working days of event:
  - Booking fee non-refundable
  - No refund for participant costs
- Participant Changes:
  - Add participants up to event day (subject to capacity)
  - No refunds for reduced numbers within 14 days
  - No refunds for no-shows

#### **Public Online Live Workshops**



- Before event start: Full refund available
- After event start: Non-refundable
- Rescheduling: Available up to 24 hours before event

### **Monthly Membership**

- Cancel subscription anytime
- No refunds for current month
- Access remains until period ends

- 28-day return period
